Dear Mr. Drockton:

This firm represents Farmers Group, Inc. and Farmers Insurance Exchange. Farmers is aware of numerous false and defamatory statements you have made regarding its employees and business practices. These statements include allegations of criminal misconduct by agents which you have made by email or through postings on a website apparently affiliated with an organization known as "Mormons4Justice" (see <https://journals.aol.com/mormons4justice>).

Be advised that your statements are false, defamatory and expose you to liability for damaging Farmers' reputation and intentionally interfering with its economic relationships. Farmers demands that you immediately cease and desist from making such statements, and that you remove all such statements from the website identified above, or any other website. Farmers also demands that you immediately cease all communications, in writing, by telephone, or in person, with any Farmers agent or employee, absent a legitimate business purpose for such communications.

We expect your full compliance with these demands within five business days of your receipt of this letter, such that you refrain from making false and defamatory statements regarding Farmers and from improperly contacting Farmers agents or employees. Your failure to do so will cause Farmers to seek to protect its rights through all available legal means, which may include legal action. If Farmers is required to initiate legal proceedings, it will seek full recovery of its damages, including its costs and attorneys' fees.
